Entering the Bahamas

US Citizens

To enter the Bahamas U.S. citizens need ONE of the three documents listed below, accompanied by a return ticket. If you are using an electronic ticket, you will need to show immigration a copy of your travel itinerary and ticket number.

Passport- Current or expired (up to maximum of five years since expiration date)

Or

Official Birth certificate. For persons 17 Years of age and older: An original certificate issued by the U.S. Govt. or court-certified copy (raised or ink seal) is required, accompanied by an official photo ID (driver's license or voter's card).

Photo ID alone is not acceptable as adequate documentation.

For persons 16 years of age and younger:

A birth certificate is all that is required. If the Traveler is a student and possesses a student ID, the traveler should also carry the student ID to facilitate being processed by Bahamas immigration.

Bahama Quick Facts

Currency: The Bahamian dollar is equivalent to the US dollar. Both are accepted throughout the Island.
Time Zone: Eastern Standard Time
Power: Standard North American 120/60 cycle AC electrical outlets.

APPRENTICE CENTER SITE VISIT

Recently, Bruce Ruinsky met with Paul Belliveau, Director of Apprenticeship and Training at the Finishing Trades Training Center to tour the facility. This state of the art apprentice training center is undoubtedly one of the most successful operations of its kind in the United States. The center boasts a wide range of equipment and materials and is staffed with expert instructors whose mission is to turn out highly trained apprentices. In an effort to increase awareness and Association involvement in the Training center, several of you have volunteered to serve on an apprentice committee which will soon meet at the facility. The success of the facility is a credit to Paul Belliveau's hard work as well as the financial support and vision of the Union and the Association of Master Painters and Decorators of New York.

OSHA

Recently, you received emails from the Association about OSHA respirator regulations. Plans are moving ahead to provide training and standardized compliance procedures. The three basic issues which will form the foundation of the program are:

1. Standardized set of written procedures.
2. Medical questionnaire and evaluation.
3. Fitment tests.

JOINT TRADE COMMITTEE

As you know the collective bargaining agreement between the Association of Master Painters and Decorators and District Council 9 provides for a Joint Trade Committee composed of representatives of both the Association and the Union. The Joint Trade Committee arbitrates charges alleging violations of the trade agreement. Frequently, charges are brought by the union against employers charging failure to file a job registration or an overtime permit. Some important and common requirements you should be aware of:

1. Association employers must register with the union prior to the commencement of any job.
2. Overtime work can only be carried out with the permission of the Union. Association employers must obtain an overtime permit from the union at least 48 hours in advance of the work to be performed, whenever possible.
3. It is the responsibility of every employer to submit weekly "Shop Steward Reports".
4. Association employers shall have no restrictions placed upon the use of the spray and paste machines. The Association is mindful of this important part of our Trade Agreement and strongly supports its enforcement.
